

2016 BBR Event Rules & Conditions

The following Rules Apply to the B.B.R. World Finals 5D Races

Eligibility & Format: Contestants must have purchased a B.B.R. Membership in 2015 and must have participated in eight (8) races at B.B.R. Qualifying Shows between January 1, 2015 and December 31, 2015. Gold Card members must have participated in six (6) races at B.B.R. Qualifying Shows between January 1, 2015 and December 31, 2015. At B.B.R.'s discretion, B.B.R. may choose to issue WORLD FINALS WILD CARD(s), in which case the rider may be exempt from these requirements. A qualified member may enter on whatever horse they choose or as many horses as they wish. However, a horse/rider combination is considered one entry and horse may not be entered by the same rider more than once. Also, a horse may not be shown by more than one person unless both contestants are members of the same immediate family and in no case shall the horse be entered more than twice. Under no circumstances will sharing of horses be allowed if one of the family members has more than one horse entered. World Finals Race will consist of Race 1 (one race over 3 days), Race 2 (one race over 3 days), and a Short go (Coliseum). Payout for Race 1 and Race 2 cannot be figured until both races are finished running on Saturday. Short go will be run slowest to fastest with beginning with back number 300 down to back number 1. (Reverse order 300-1).

Entry: World Finals Race entries must be postmarked no later than March 15, 2016. No late entries will be accepted. All entries are final. **There will be no refunds given for any reason.** All entries are for the rider, not the horse. Those wishing to sell their entry must do so no later than 5:00 pm, April 1, 2016. All sales/purchases must take place through the B.B.R. office, and there will be a \$50 substitution fee per entry payable by the buyer. Those wishing to sell or purchase a position must contact the B.B.R. office by phone at (405) 230-7167. B.B.R. will match available positions to those wishing to purchase them on a first-come, first-serve basis. Entries may only be sold to another qualified B.B.R. member. Fees for buy-out entries must be paid by credit card. B.B.R. will send a refund check to the seller of the position only after the proper fees have been received from the contestant purchasing the entry. Better Barrel Races, LLC does not guarantee that entries will be available for purchase or that all contestants wishing to sell their entry will receive a refund. Refunds checks will be issued by B.B.R. on or about May 1, 2016.

Horse substitution will be allowed thru check-in. Substitutions will not be allowed after a horse has been checked-in and numbered.

Rider substitution will be allowed thru check-in for a \$50 fee so long as the original horse entered in that position is not substituted. Switching of draw positions will not be allowed. Substitute rider must also be another qualified B.B.R. member.

Age-Based Side Pots: Any contestant entered in the BBR World Finals 5D (Race 1 and Race 2) may also enter one of three age-based incentive side-pots. \$50 Entry Fee with 75% payback. The age-based incentive side-pots are based on the age of the rider as of January 1, 2016. The three groups are: Youth (15 & under), Adult (16-49), and Senior (50 & over). A contestant may only enter the side-pot corresponding to his/her age. Times will be carried from your Race 1 and Race 2 runs to the side-pot races. The format will be a 5D with ½ sec splits for the age based side-pots. Money will be split evenly between the two qualifying races and the number of places paid will be determined by the number of entries in each side-pot.

Running Order will be posted on line for contestant convenience prior to the event at www.betterbarrelraces.com and also in the office during the event.

World Finals Races Competition Rules: Qualifying rounds and the short-go will be paid on a 5D format with half-second splits. The number of places paid will be determined by the total number of entries. See BBR web site for recommended payout per number of entries.

The short go will be comprised of qualifiers based on 5D with half-second splits and will pay the same number of places as the long-goes. A minimum of 300 contestants will qualify for the short go with 30 contestants from each division of each qualifying race being invited back to the short go.

If a contestant places in any division on the same horse during both qualifying rounds, the person placing directly behind them in each race will be added to the short go. Finals qualification will be based on placing in the long-goes. If a contestant qualifying for the short go chooses not to compete, no additional contestants will be added.

The running order for the short go will be run in qualifying time order, beginning with slowest (Back #300) to fastest (Back #1). Back numbers must be worn in the World Finals 5D Short Go Round – NO EXCEPTIONS!

B.B.R. Gold Card Members Only 5D Race Rules

Eligibility & Format: Open to current Gold Card members whose membership is valid thru April 24, 2016. Gold Card Members Race will consist of one race run over a period of 3 days, Thursday, Friday and Saturday. Gold Card Members also competing in the World Finals Race 1 and Race 2 will be drawn so they are not competing on the same day in both races.

Entry: Gold Card Members Race entries must be postmarked no later than March 15, 2016. **Late entries will be accepted with \$15 late fee (one time per horse) thru April 23, 2016 at 1pm. All entries are final. There will be no refunds given for**

any reason. Fees for late entries must be paid by cash or credit card. All entries are for the rider, not the horse.

B.B.R. Youth 5D Race Rules

Eligibility & Format: Open to current members whose membership is valid thru April 24, 2016. Youth Race will consist of one race run over a period of 3 days, Thursday, Friday and Saturday. Youths also competing in the World Finals Race 1 and Race 2 will be drawn so they are not competing on the same day in both races.

Entry: Youth Race entries must be postmarked no later than March 15, 2016. **Late entries will be accepted with \$15 late fee (one time per horse) thru April 23, 2016 at 1pm. All entries are final. There will be no refunds given for any reason.** Fees for late entries must be paid by cash or credit card. All entries are for the rider, not the horse.

B.B.R. New Members & Non Qualifiers 5D Race Rules

Eligibility & Format: Open to New 2016 Members or 2015 Members (with current 2016 membership) who did NOT Qualify for the 2016 B.B.R. World Finals 5D Race. NMNQ Race will be one race run over a period of 3 days, Thursday, Friday and Saturday.

Entry: Contestants may enter the NMNQ race twice on the same horse, but will be drawn on different days when doing so. NMNQ Race entries must be postmarked no later than March 15, 2016. **Late entries will be accepted with \$15 late fee (one time per horse) thru April 23, 2016 at 1pm. All entries are final. There will be no refunds given for any reason.** Fees for late entries must be paid by cash or credit card. All entries are for the rider, not the horse.

B.B.R. Gold Card Members, Youth & NMNQ Competition Rules

Current B.B.R. Membership Required: Contestants must be current B.B.R. members and may send in B.B.R. Membership with entry form to enter these races. Members meeting the criteria for these races may enter on whatever horse they choose or as many horses as they wish. However, a horse/rider combination is considered one entry. Also, a horse may not be shown by more than one person unless both contestants are members of the same immediate family and in no case shall the horse be entered more than twice. Under no circumstances will sharing of horses be allowed if one of the family members has more than one horse entered.

Horse substitution will be allowed thru check-in. Once a horse has been checked in it may not be substituted.

Rider substitution will be allowed thru check-in for a \$50 fee so long as the original horse entered in that position is not substituted and the rider is a current B.B.R. Member. If substitute rider is not a current B.B.R. Member they must purchase membership before competing. A substituted rider must be eligible for the New Member & Non Qualifiers race. Switching of draw positions will not be allowed.

Running Order will be posted on line for contestant convenience prior to the event at www.betterbarrelraces.com and also in the office during the event.

Check In: Current Negative Coggins test (dated within 1 year of April 24, 2016) and Health Papers (dated within 30 days of April 24, 2016) are required at check in. HORSES WILL NOT BE NUMBERED WITHOUT THESE DOCUMENTS.

Competition Rules: New Member/Non Qualifier, Gold Card Members & Youth Races will be paid on a 5D format with half-second splits. The number of places paid will be determined by the total number of entries. See BBR web site for recommended payout per number of entries.

The following Rules Apply to the B.B.R. Insurance 5D Race

Eligibility & Format: Open to World Finals 5D contestants who do not make the World Finals Short Go. Entry is defined as a rider/horse combination.

Entry: **\$35 Insurance Fee** must be paid with World Finals Entry prior to event.

Running Order: Running order will be random draw, posted Saturday night, April 24th after Short Round Finalists have been determined. Contestants who have paid the Insurance Fee and qualify for the World Finals 5D Short Go will forfeit their Insurance Fee and will not be included in the Insurance Race Draw.

Insurance Race Competition Rules: Insurance Race will be paid on a 5D format with half-second splits. The number of places paid will be determined by the total number of entries. See BBR web site for recommended payout per number of entries.

The following Rules Apply to the B.B.R. Slot Race & Futurity

Slot Race: Open only to horses 4 years old & under in 2016 (foals of 2012 or after) that have never competed in barrel racing for money, points or prizes, prior to December 1, 2015. All slot horses must also be entered in the B.B.R. Futurity. Slot Race Format will be one run with straight payoff. Competition is limited to 30 horses, 1 horse per rider, and 1 slot per owner. Slot race competition will be run at the beginning of the Futurity Qualifying round.

Futurity: Open to 5 year olds & under of 2016 (foals of 2011 or after) that have never competed in barrel racing for money, points or prizes, prior to December 1, 2015. Futurity format is 2 rounds, with 1st round being the Qualifying round. Top 30 fastest, by time run, will proceed to Championship round, remaining field including penalties and no-times, will proceed to Consolation round (horses must compete in the Qualifying round to run in the Consolation round).

2016 BBR Event Rules & Conditions

Payoffs: The payoff for the Slot race will be 90% payback, with a straight pay off and one place being paid for every 4 paid in full entries. The payoff for Futurity will be 75% of entry fees plus 100% of added money. The Futurity Championship Round and the Consolation Round will be a straight pay off. Futurity shall pay one place for every 10 entries. Total number of places paid in the Futurity will be split evenly between Championship Round and Consolation Round with 70% of the purse going into the Championship Round and 30% of the purse going into the Consolation Round. Should the number of places paid be an odd number, one more place will be paid in the Championship Round than will be paid in the Consolation (for example if 150 entries are received would result in 15 places paid, 8 would be paid in the Championship Round and 7 would be paid in the Consolation).

Tie for Purse & Prizes: If any contestant's times are tied, the prize money will be split equally and a total time on two runs (qualifying round + championship round times) will determine the winner of the awards. Should a tie still exist a roll of the dice shall determine the awards winner, high roll wins.

General Rules for All Classes at B.B.R. World Finals Event

Check In: *ALL CONTESTANTS MUST SHOW Current Negative Coggins test (dated within 1 year of April 24, 2016) and Health Papers (dated within 30 days of April 24, 2016) are required at check in. HORSES WILL NOT BE NUMBERED WITHOUT THESE DOCUMENTS.*

General Check-In will be in Barn 3 Warm Up Arena Wednesday and Thursday. ALL HORSES RIDDEN BY BBR MEMBERS WITH A STANDARD MEMBERSHIP MUST BE CHECKED-IN AND NUMBERED BY CLOSE OF CHECK-IN THURSDAY.

Futurity Horse Check-In will be in the Super Barn Warm Up Arena on Wednesday. Those wishing to get their exhibitions should bring saddled horses to the Check-In & Number Station for EXPRESS CHECK-IN. **FUTURITY CONESTANTS MUST ALSO PROVIDE HORSE REGISTRATION PAPERS AT CHECK-IN.**

Gold Card Members EXPRESS Check-In will be in the Super Barn warm up arena on Wednesday, Thursday, Friday and Saturday. Gold Card members may check in and number horses up to 1 hour prior to competition.

Dress Code will be enforced, including cowboy hat or safety riding helmet, long sleeve button down or snap front shirt with collar (no sweat shirts, hoodies or lace sleeve, or burn out t's), long pants with NO HOLES (this means: no skin showing, no sewn on patches, no duct tape, etc.), cowboy boots or equine sports shoes.

Customary Tack shall be defined as bridle (with a bit and/or a noseband), saddle, saddle pad or saddle blanket, protective foot and leg boots, tie-down, bonnet, martingale or german-martingale, split reins, draw reins, are all considered to be standard and customary articles of tack used in barrel racing. B.B.R. contestants are prohibited from competing bareback, and/or bridle-less. Any articles of tack or performance enhancing gear which impede B.B.R.'s ability to hip number horses, or identify horses are prohibited in B.B.R. competition. Use of such prohibited tack or performance enhancing gear shall result in a disqualification with no refund of entry fees.

Contestants shall identify themselves to the arena coordinator located outside the warm-up pen next to the alleyway before their name will be called in the arena. Failure to do so will result in a no time. Contestants must be in the holding area and ready when their name is called. Contestants will have 60-second time limit, commencing from announcer's first call, to enter the arena. Three calls, and only three calls will be given. Failure to enter the arena within this time limit will result in a No-Time.

If a contestant competes out of turn, he/she will receive a no-time. Contestants running more than one horse must run the horses in the position in which named horses are drawn or they will receive a no-time.

Any barrel knocked down in divisional competition will result in a no-time. Barrels knocked down in Slot Race, or Futurity competition will receive a 5-second time penalty added to run.

Contestants must be mounted and must maintain forward motion once they enter the competition arena. The competition arena is defined as any point past the arena gate. Circling, stopping or backing horses after entering through the arena gate is strictly prohibited and will result in a no-time. Contestant may be led by an un-mounted assistant through the gate into the alley, horse must not be stopped, turned or circled after crossing the threshold of the gate.

Contestants are not to train or circle a barrel more than once during competition. Such behavior will result in a no-time and a \$25 fine will be assessed payable in the show office within 1 hour their run.

No re-runs will be given if a horse falls, is pulled up by the rider or in the event of a rider's equipment malfunction.

An electric timer will be used for all runs. In the event of a timer failure, a re-ride will be granted and any penalties incurred during original run will apply. Contestant shall contact the arena judge immediately to determine the position of their re-run. If a barrel is knocked down during the re-run, that penalty will apply.

Animal Abuse. IMPORTANT NOTICE: The welfare of the horse and all other animals is paramount to BBR. Anyone who excessively whips or spurs, and/or strikes a horse's ears, eyes or face with anything other than the hand, either in the arena or on the facility grounds will be fined \$100. Any rider caught using an electronic device on a horse during competition will be automatically disqualified and shall forfeit all winnings. Horses shall not be left unattended while bitted-up or tied-around on facility grounds at any B.B.R. sanctioned or produced event. Inhumane treatment, or neglect, of any horse or dog during a B.B.R. event will not be tolerated. An individual who has been warned by a B.B.R. Representative for such behavior and persists or refutes the warning shall be fined an additional \$100. Individuals who fail to pay incurred fines will remain ineligible for competition at B.B.R., LLC events, until such time as all fines have been paid. First offenses will be punished by a fine being imposed. A second offense will be dealt with by the B.B.R. Founders and may result in a fine of up to \$5,000 (to be donated to a non-profit animal rescue center) and a suspension of membership.

Safety: Safety is a prime objective at this barrel race. If you have a horse that could be dangerous to yourself, other contestants, or other horses, DO NOT bring it to this barrel race. Any horse or contestant deemed to be dangerous by the management of B.B.R. will be disqualified and entry fees will not be refunded. Better Barrel Races, LLC does not assume any responsibility for personal injury, loss, theft or damage. Contestants and all other parties recognize barrel racing as a hazardous sport and participate at their own risk.

Disqualifications: Any act deemed prejudicial to the best interests of B.B.R. may result in the disqualification of the contestant, with no refund of entry fees. The contestant may also be placed upon the B.B.R. "ineligible" list. These acts may include but are not limited to the following:

- Using abusive or intemperate language or attempting to threaten, bribe, influence, or harass any contestant, spectator, staff member, or Arena Personnel. Also, any remarks made with the intent to cast aspersions on the character or integrity of a B.B.R. staff member or management member.
- Moving or attempting to move markers at any time.
- Use of electronic and/or remotely controlled devices to alter the outcome of a run.
- Abuse or neglect of a horse or dog as defined within these rules.
- Competing while under the influence of drugs or alcohol.
- Misidentifying a horse in any B.B.R. Barrel Race class.
- Misidentifying a rider in any B.B.R. Barrel Race class.
- Other conduct that is not in the best interest of the B.B.R., or its contestants.
- Failure to make good on a returned check to the B.B.R., to any B.B.R. Independent Producer, or B.B.R. Vendor.
- Failure to pay any fines within one hour of fine being incurred during the B.B.R. World Finals may result in contestant disqualification.
- The B.B.R. Management at their sole discretion shall have the authority to disqualify or deny entry to any horse they deem dangerous to the rider, or to other individuals, animals or property.

Payout Check Distribution: Checks will only be issued at the conclusion of the competition to individuals who have a completed W-9 tax form on file in the show office. Checks will be issued in the name of the rider in all classes except futurity and slot race, in which case checks will be issued to the horse owner, or slot owner, on record. B.B.R. reserves the right to hold all prizes (check and awards) until a completed W-9 has been submitted. B.B.R. also reserves the right to withhold balances due B.B.R., from the winnings of individuals who have outstanding accounts.

Barn & Stalls

All stalls will be pre-assigned. Contestants riding a stallion or a problem horse must send a written request for special accommodations for that horse with their entry. These individuals will be given special consideration for stalling. There are no written or implied guarantees that tack stalls will be available at all locations. Contestants wishing to be stalled together must send their entries in the same envelope. However, B.B.R. does not guarantee its ability to stall contestants next to each other as per their requests.

All horses staying on the grounds must be stalled in the accommodations provided by B.B.R. Overnight tying of horses is strictly prohibited. There will be absolutely no tying of horses in the warm-up areas, round pens, and/or alley ways of the stall barns at any time. Round Pen turn outs will be available in 20 minute sessions for a nominal fee. Owners will be required to stay with their horses during these sessions to insure the horse will be removed at the end of the session.

Any horse found in a stall that has not been assigned specifically to it, or any horse found loose or tied and unattended will be locked in an empty stall. The owner must purchase that stall (\$85) before horse will be released or allowed to compete.

No outside bedding will be allowed. Shavings will be available for purchase at the fairgrounds Feed & Bedding Office (405) 948-6786.

All paid stalls will be tagged or marked with the rider's name.

2016 BBR Event Rules & Conditions

Any nails, tacks or wire used in or on stalls must be removed prior to move-out. Excessive use of nails, tacks, wire or any similar material is prohibited.

Horses are not permitted on lawns, medians, or on the East (front) side of barns.

No electric cords will be allowed to lie on the ground or hang suspended in any area used or traversed by horses.

Any horse owner or rider wishing to remove stall panels or dismantling pre-constructed stalls must receive express written consent from the B.B.R. Show Office. There is a \$500 Fee for the removal or dismantling of pre-constructed stall panels.

Wash racks are located in the Super Barn, Barn 6 and Barn 8. Do not wash horses in stalls, alleyways, streets or any other area other than the designated wash racks.

Place all stall cleanings in the designated receptacles. Do not place stall cleanings in the alleyways or trash barrels.

As per Oklahoma State Fair Park Rules: All dogs must be kept on a leash. No dogs are allowed in the host facility, restrooms, concession stands or in the Jim Norick Coliseum Arena at Oklahoma City. A \$50 fine will be imposed for failure to follow these rules.

Parking & Camping

No vehicles, including automobiles, trucks, trailers, RV's, golf carts, scooters, bicycles, etc., are allowed inside the barns (with the exception event and facility staff) or on the lawns at any time.

Overnight camping with hook-ups is allowed only in the State Fair RV Park. Utility connections (electric, gas, water, sewer) to vehicles from any barn area source is strictly prohibited.

Area traffic/parking signs are to be observed at all times.

Designated fire lanes must be kept clear at all times. **The roads immediately adjacent to either side of the stall barns are for unloading only!** Vehicles must be moved immediately after unloading. No parking will be allowed along Barn Row or along Gordon Cooper Blvd. on the East side of barns. Any contestant who fails to move a vehicle from a loading/unloading zone as requested by a B.B.R. staff member or a facility representative will incur a \$100 fine.

After unloading, all trailers are to park on the North end of the stall barns, or in the parking areas South of the railroad tracks. No trailers are to be parked in the lots East of Gordon Cooper Blvd or North of the railroad tracks

Vehicles parked in unauthorized areas will be towed at the owner's expense.

Miscellaneous

A \$100 charge will be assessed for every check returned to B.B.R. by the bank marked insufficient, closed account or stop payment. Anyone who fails to pay the return check charge will remain ineligible for nomination to subsequent B.B.R. Founders' events, until such time as all return check charges have been paid.

All fines are to be paid in cash in the show office. Contestants with outstanding fines will not be allowed to compete until such time as fine(s) has been paid.

The posting of signs, advertisements, posters, bumper stickers, or cards on any surface other than bulletin boards is prohibited.

Selling of merchandise or professional services on the grounds, in stalls, or at trailers is prohibited unless you are a vendor contracted with Better Barrel Races, LLC.

Damage willfully caused to any property, i.e., stalls, barns, grandstands, etc. of B.B.R., its representatives, the Host Facility or Host Hotel, shall be paid for by the contestant or their representative before being allowed to continue to participate at the B.B.R. World Finals.

Any questions or disputes which may arise during the course of the B.B.R. World Finals not covered by the above rules will be decided and settled by Better Barrel Races, LLC. This decision will be final.

Photo & Video Rules: Better Barrel Races, LLC retains all rights to every photo and/or video taken on the Oklahoma State Fair Park grounds during the BBR World Finals event. Contestant grants Better Barrel Races, LLC the right to use any photographs or video of him/her taken at the B.B.R. World Finals, including but not limited to those of any contestant during competition or while otherwise attending the event, for publicity purposes. Contestant agrees that no photographic or video images taken of the competition or exhibition areas will be altered or copied without the express written consent of Better Barrel Races, LLC and the photographer/videographer. **Contestants are expressly prohibited from taking pictures/videos of photographer/videographer proofs or recorded runs at the viewing booths unless approved by the event videographer or photographer.** B.B.R.

press credentials are required for all commercial photographers or videographers on the State Fair Park grounds during the B.B.R. World Finals. Credentials can be obtained in the show office. Individuals without prior approval and proper Better Barrel Races press credentials will be asked to leave the premises.

Better Barrel Races, LLC does not assume any responsibility for personal injury, loss, theft or damage. Contestants and all other parties recognize barrel racing as a hazardous sport and participate at their own risk.

Better Barrel Races, LLC reserves the right to make any changes to the B.B.R. World Finals, it deems necessary, including cancellation. B.B.R. assumes no responsibility for providing any notice of changes to any contestant. Any notice provided by Better Barrel Races, LLC is only for the convenience of the contestant.

Resolutions of Disputes: It is recognized that Better Barrel Races, LLC has established the rules and conditions for participation in the B.B.R. World Finals. By participating in this program and/or entering this contest each participant agrees to be bound by rules and conditions as established by and as interpreted by Better Barrel Races, LLC. In the event of a dispute with respect to any matter governing the award of prizes, awards and monies, the decision by Better Barrel Races, LLC shall be final, binding and not subject to challenge in any court of law.

In the event a lawsuit is filed, the parties hereto consent to WAIVE THEIR RIGHT TO A JURY TRIAL concerning any controversy arising out of or relating to any of the parties' dealings with each other, whether in contract or in tort, AND TO SUBMIT ANY AND ALL DISPUTES TO ARBITRATION pursuant to the provisions of the Oklahoma Uniform Arbitration Act found at 15 O.S. §801, et seq. The arbitration proceedings shall be conducted in accordance with the provisions of 15 O.S. §801, et seq. and, specifically, pursuant to the provisions of 15 O.S. §804, in the event a lawsuit is filed, Better Barrel Races, LLC may apply to the Court for the appointment, in the sole discretion of the Court, of a single arbitrator which said arbitrator will arbitrate said dispute in accordance with the provisions of the Oklahoma Uniform Arbitration Act. Each participant agrees that in the event of an unsuccessful lawsuit, the claimant shall be liable for Better Barrel Races, LLC costs and attorney's fees. Each Participant also agrees (a) that the B.B.R. World Finals, as described in the conditions, bears a reasonable relationship to the state of Oklahoma; (b) that the rules, conditions and conduct should be governed by the laws of the state of Oklahoma in all respects, and (c) that Cleveland County, Oklahoma shall be the choice of venue. It is the sole responsibility of each participant to make timely payments to maintain entry eligibility. Neither Better Barrel Races, LLC, nor its directors, accepts responsibility for providing any notice of deadlines or eligibility to any member. Any notice provided by Better Barrel Races, LLC is only for the convenience of the members. Failure to mail or receive any notice shall in no way absolve the member from ultimate responsibility to insure timely payment(s). Better Barrel Races, LLC may elect to provide entry reminder notices, eligibility lists or any other notice but is under no obligation to do so.

All parties involved in the B.B.R. World Finals are responsible for reading these conditions and fully understanding their contents. Better Barrel Races, LLC assumes no liability to those who have not read the conditions and having not read these conditions they are still held to their contents.

Regional Year-End Awards

The B.B.R. Regional Year-End Awards will include a Top 10 in each division. Members winning awards do not have to be entered in the B.B.R. World Finals. However, there will be an awards presentation for Regional Hi-Point Saddle winners on Friday, April 26th at 7:00pm. Saddle Winners who are entered at the Finals MUST be present and in Dress Code to receive their saddle and for awards presentation photo, members who fail to do so will forfeit their saddle. Members who are not entered must designate someone to stand in for them (in full dress code) for the saddle presentation awards picture, members who fail to do so will forfeit their saddle. All awards need to be picked up in the show office during the Finals (beginning Friday morning at 9am). Awards winners not able to claim their prizes in person must designate someone to do so in writing to the B.B.R. Office no later than April 15th. Prizes not claimed at the Finals will be forfeited.
